

# **IBPS PO Exam Date 2024 - Eligibility**

Before you apply for the IBPS PO 2024 exam, ensure you meet the following eligibility criteria: educational background, computer skills, language proficiency, and age.

#### **Educational Qualification**

• You need to have a Degree (Graduation) in any discipline from a university recognized by the Government of India or an equivalent qualification approved by the Central Government. You must also have a valid mark-sheet or Degree Certificate to prove you are a graduate at the time of registration. Additionally, you will need to indicate the percentage of marks obtained in your Graduation when you register online.

### Nationality/Citizenship

To apply for the IBPS PO exam, you must be:









- 1. An Indian citizen, or
- 2. A subject of Nepal or Bhutan, or
- 3. A Tibetan refugee who came to India before January 1, 1962, with the intention of permanently settling in India, or
- 4. A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, Vietnam, or East African countries like Kenya, Tanzania, Uganda, Zambia, Malawi, Zaire, or Ethiopia with the intention of permanently settling in India.

If you fall under categories 2, 3, or 4, you must have a certificate of eligibility issued by the Government of India.

## Age Limit (as on 01.08.2024)

· You must be at least 20 years old and no older than 30 years to apply. This means you should have been born on or between August 2, 1994, and August 1, 2004.

However, there are age relaxation rules for candidates from different categories as per government regulations:



#### **Preliminary Exam**

- You have 1 hour to complete the online test.
- The exam consists of three sections: English Language, Quantitative Aptitude, and Reasoning Ability.
- There are 100 questions, totaling 100 marks.
- There is a negative marking system with a penalty of 0.25 marks for each incorrect answer.
- To advance to the IBPS PO Main exam, you must achieve the cut-off marks in all three sections.

### **Mains Exam**

- The IBPS PO Main exam is conducted online and features five sections: four objective sections and one descriptive section.
- The total score for the objective sections is 200 marks, while the descriptive section carries 25 marks.
- You have 180 minutes to complete the objective sections, with an additional 30 minutes for the descriptive paper.
- The descriptive paper assesses your written communication skills, which are crucial for the Probationary Officer role.
- Each wrong answer deducts one-fourth of the marks assigned to that question. For instance, if a question carries 1 mark, 0.25 marks will be deducted for an incorrect response.
- · However, no marks will be deducted if you leave a question unanswered.
- To qualify for the interview stage, you need to pass both the preliminary and main exams.

#### Interview





- If you qualify for the mains exams, you will be called for a personal interview.
- The personal interview is worth 100 marks.
- You need to score at least 40% in the interview to make it to the merit list.
- Once the interview round is over, IBPS will publish the merit list on their official website.
