

### Nationality:

If you are applying for IBPS Clerk Exam 2024 then you must be either:

- A Citizen of India
- A subject of Nepal/Bhutan
- A Tibetan Refugee who arrived in India before 1st January 1962 with the intention of permanent settlement in India.
- A person of Indian origin who migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, or Vietnam with the intention of permanent settlement in India.

## IBPS Clerk Eligibility Criteria 2024 - Important Check Points

### Age Limit (As on 01.07.2024):

- You must be between 20 and 28 years old to be eligible for IBPS Clerk exam 2024. To elaborate you must have been born not earlier than 02.07.1996 and not later than 01.07.2004 (both dates inclusive).

Moreover, the age relaxation criteria are as follows:

Sr.No.	Category	Age relaxation
1	Scheduled Caste/Scheduled Tribe	5 years
2	Other Backward Classes (Non-Creamy Layer)	3 years
3	Persons with Benchmark Disabilities	10 years
4	Ex-Servicemen / Disabled Ex-Servicemen	The actual period of service rendered in the defence forces plus 3 years (8 years for Disabled Ex-Servicemen from SC/ST) is subject to a maximum age limit of 50 years.
5	Widows, divorced women and women legally separated from their husbands who have not remarried	Age concession up to the age of 35 years for General/EWS, 38 years for OBC and 40 years for SC/ST candidates
6	Persons affected by 1984 riots	5 years

### Educational Qualification (As on 21.07.2024):

The educational qualifications needed for the IBPS Clerk exam 2024 are outlined as below:

## IBPS Clerk Eligibility Criteria 2024 - Important Check Points

- You must have a degree (graduation) in any discipline from a university recognized by the Government of India or an equivalent qualification recognized by the Central Government.
- Operating and working knowledge of computer systems is mandatory, so you should have a certificate, diploma, or degree in computer operations/language or should have studied Computer/Information Technology as one of your subjects in high school, college, or institute.
- It is preferable that you know how to read, write, and speak the official language of the state/UT for which you are applying.

The IBPS Clerk Exam Pattern 2024 consists of two distinct phases: Prelims and Mains, each with different marking schemes and time allocations. Below, we will go into the details of each phase to understand the IBPS Clerk Exam Pattern and duration:

### IBPS Clerk Prelims Exam Pattern 2024:

The prelims exam for IBPS Clerk consists of three sections carrying a total of 100 marks. It is an online objective-based test with a duration of one hour. - The total number of questions in the IBPS Clerk Exam is 100.
- The preliminary examination carries a maximum of 100 marks.
- Each correct answer in the exam awards you 1 mark.
- There is a negative marking system in place, where 0.25 marks are deducted for each wrong answer.
- The duration of the preliminary examination is 60 minutes.

The IBPS Clerk mains exam to be conducted in the month of October 2024 will feature a total of 190 questions. You will have 160 minutes to complete this objective-based online test.

- There is a negative marking system where 0.25 marks are deducted for each wrong answer.
- The duration of the mains examination is 160 minutes.
- You must qualify for the preliminary examination to be eligible for the mains examination.
