

Nationality

To be eligible, you must be:

- An Indian citizen, or
- A subject of Nepal or Bhutan, or
- A Tibetan refugee who settled in India before January 1, 1962, or
- A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, or East African countries such as Kenya, Uganda, Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, and Vietnam with the intention of permanently settling in India.

If you fall into the last three categories, you must have a certificate of eligibility issued by the Government of India.

Educational Qualifications (As of 21.08.2024)

IBPS PO Eligibility Criteria 2024 - Age, Education

- Hold a Graduation degree from a recognized University or an equivalent qualification approved by the Central Government.
- Possess a valid mark sheet or Degree Certificate on the day of registration and provide your graduation marks percentage online.

Age Limit (As of 01.08.2024)

You must be between 20 and 30 years old to qualify for the IBPS PO exam.

Online applications began on August 1, 2024, and the deadline to submit your application is August 21, 2024. Preliminary Examination

a. Preliminary Examination (Objective Test)

You have 1 hour to complete the online test. The exam includes three sections: English Language, Quantitative Aptitude, and Reasoning Ability. There are 100 questions, each worth one mark, totaling 100 marks. A penalty of 0.25 marks is applied for each incorrect answer. To proceed to the IBPS PO Main exam, you must meet the cut-off marks in all three sections.

The IBPS PO Main exam is conducted online and comprises five sections: four objective sections and one descriptive section. The objective sections have a total score of 200 marks, while the descriptive section is worth 25 marks. You have 180 minutes for the objective sections and an additional 30 minutes for the descriptive paper, which evaluates your written communication skills essential for the Probationary Officer role. Each wrong answer in the objective sections results in a deduction of one-fourth of the marks assigned to that question. No marks are deducted for unanswered questions. To advance to the interview stage, you need to pass both the preliminary and main exams.

Interview

Upon qualifying for the main exams, you will be invited for a personal interview, which is worth 100 marks. To be included in the merit list, you need to score at least 40% in the interview. After the interview round, IBPS will publish the merit list on their official website.

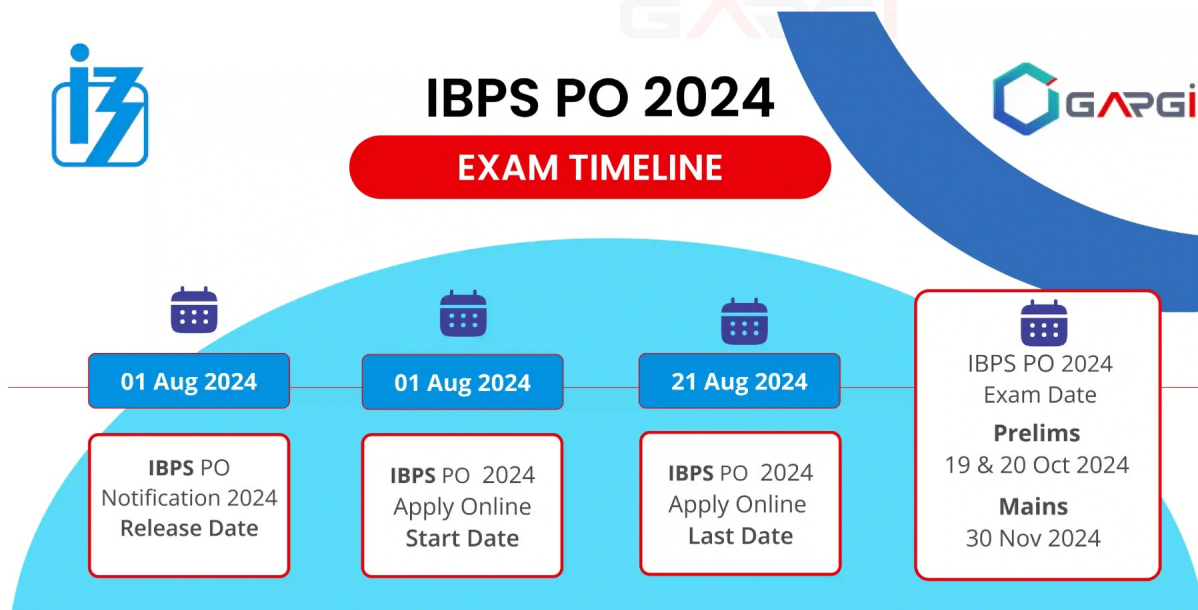
