## Nationality

To be eligible for the IBPS RRB Clerk 2024 Exam, a candidate must fall under one of these categories:

## IBPS RRB Clerk Eligibility Criteria 2024 - Important Check Points

- a Citizen of India or
- a subject of Nepal or
- a subject of Bhutan or
- a Tibetan Refugee who came over to India before January 1, 1962, to permanently settle in India.
- a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam intending to permanently settle in India.

If you belong to any of the last four mentioned categories, you must possess a certificate of eligibility issued by the Government of India.

## Age

The age limit criteria for the IBPS RRB Clerk exam 2024 are as follows:

- The candidate's age must be between 18 years and 28 years.

## Educational Qualification

The mandatory education qualifications for IBPS RRB Clerk Exam 2024 include:

- You must hold a bachelor's degree in any discipline from a recognized university or its equivalent.
- Also must be proficient in the local language as prescribed by the participating RRBs.
- And they should have basic working knowledge of computers.

## IBPS RRB Clerk Notification 2024

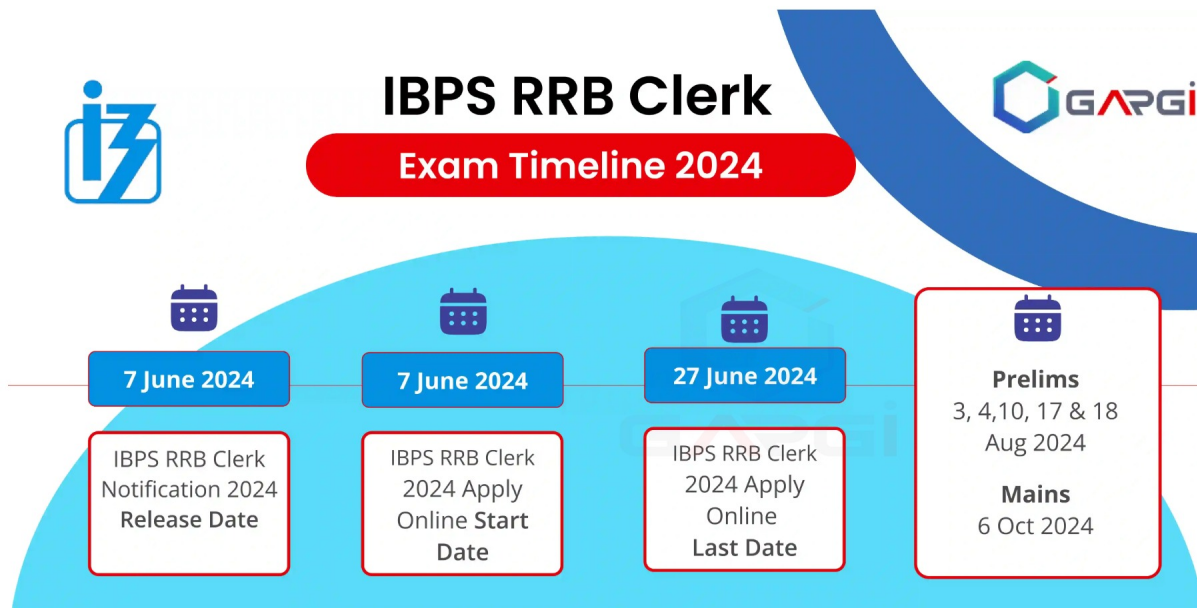
