#### Nationality

The candidate must be:

## IBPS RRB Eligibility Criteria 2024 - Important Check Points

- A citizen of India
- A citizen of Nepal
- A citizen of Bhutan
- A Tibetan Refugee who came over to India before 1st January 1962 with the intention of permanently settling in India
- A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

### Age

Thereafter, the age limit for candidates varies according to the post they are applying for.

- For the post of Office Assistants (Multipurpose), the age limit is between 18 years and 28 years.
- For the post of Officer Scale- I (Assistant Manager), the age limit is between 18 years and 30 years.
- For the post of Officer Scale- II (Manager), the age limit is between 21 years and 32 years.
- For the post of Officer Scale- III (Senior Manager), the age limit is between 21 years and 40 years.

### Educational Qualification

Just like the age criteria, the educational qualification that the candidates must possess varies according to the post they apply for.

- **Office Assistants (Multipurpose):** Must possess a Bachelor's degree in any discipline from a recognized University or its equivalent.
- **Officer Scale-I (Assistant Manager):** Must possess a Bachelor's degree in any discipline from a recognized University or its equivalent and degree in Agriculture, Horticulture, Forestry, Animal Husbandry, Veterinary Science, Agricultural Engineering, Pisciculture, Agricultural Marketing and Cooperation, Information Technology, Management, Law, Economics or Accountancy.
- **Officer Scale-II General Banking Officer (Manager):** Must possess a Bachelor's degree in any discipline from a recognized University or its equivalent with a minimum of 50% marks in aggregate and degree in Banking, Finance, Marketing, Agriculture, Horticulture, Forestry, Animal Husbandry, Veterinary Science, Agricultural Engineering, Pisciculture, Agricultural Marketing and Cooperation, Information Technology, Management, Law, Economics and Accountancy.
- **Officer Scale-II Specialist Officers (Manager):** This post is further bifurcated into three posts:
  - Information Technology Officer: Must possess a Bachelor's degree from a recognised University in Electronics / Communication / Computer Science / Information Technology or its equivalent with a minimum of 50% marks in aggregate.
  - Chartered Accountant: Must be a Certified Associate (CA) from Institute of Chartered Accountants of India.
  - Law Officer: Must possess a Degree from a recognised University in Law or its equivalent with a minimum of 50% marks in aggregate.
  - Treasury Manager: Must be a Chartered Accountant or MBA in Finance from a recognized university/ institution.
  - Marketing Officer: Must possess an MBA degree<sup>2</sup> in Marketing from a recognized university.
  - Agricultural Officer: Must possess a Bachelor's degree in Agriculture/ Horticulture/ Forestry/ Animal Husbandry/ Veterinary Science/ Agricultural Engineering/ Agricultural Marketing and Cooperation/ Information Technology/ Management/ Law/ Economics and Accountancy from a recognized university.

### For the Office Assistant (Multipurpose) position:

- There are two tests, each consisting of 40 questions worth one mark each.
  - Reasoning - 40 marks
  - Numerical Ability - 40 marks

### For Officer Scale-I:

- There are two exams, each containing 40 questions worth one mark each.
  - Reasoning - 40 marks
  - Quantitative Aptitude - 40 marks
