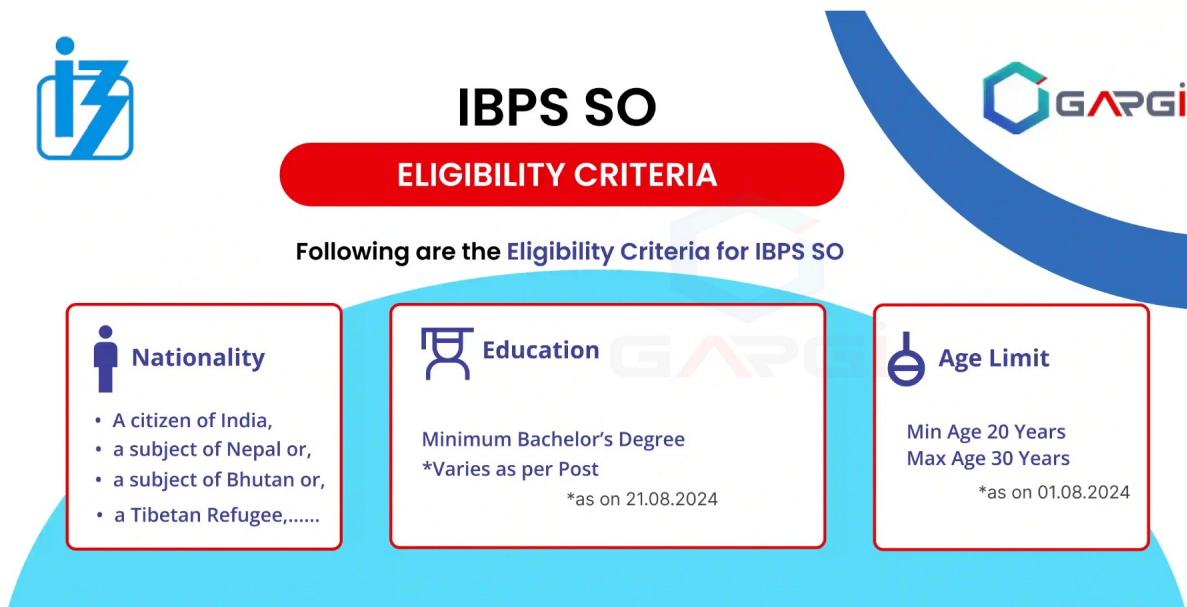


IBPS SO Eligibility Criteria 2024 - Age, Education

IBPS SO Eligibility Criteria 2024

Want to know if you meet the IBPS SO Eligibility Criteria 2024? You are in the right place. There are three main eligibility criteria for the IBPS SO exam in 2024, which are nationality, age limit, and educational qualification.

You need to fit these criteria to be eligible for the IBPS SO 2024. The IBPS SO Eligibility Criteria 2024 is given in the points below.

Nationality

You must be either:

- a citizen of India or
- a subject of Nepal or
- a subject of Bhutan or
- a Tibetan refugee who came over to India before January 1, 1962, intending to permanently settle in India or
- a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, the East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, and Vietnam, intending to permanently settle in India.

IBPS SO Eligibility Criteria 2024 - Age, Education

Age Limit (As on 01.08.2024)

You must be between the ages of 20 and 30. A candidate must have been born not earlier than 02.08.1993 and not later than 01.08.2003 (both dates inclusive). Moreover, there are a few relaxations to the upper age limit for specific categories. They are as follows:

- By 5 years for Scheduled castes and scheduled tribes candidates.
- By 3 years for Other Backward Classes.
- By 10 years for Persons with Benchmark Disability as defined under “The Rights of Persons with Disabilities Act, 2016”.
- Ex-servicemen, Commissioned Officers including Emergency Commissioned Officers (ECOs)/ Short Service Commissioned Officers (SSCOs) who have rendered at least 5 years of military service and have been released on completion of the assignment, will get 5 years of the upper age limit.
- By 5 years for people affected by the 1984 riots.

Educational Qualification (As on 21.08.2024)

IBPS SO recruits candidates for various posts like I.T. Officer, Agricultural Field Officer, Rajbhasha Adhikari, Law Officer, HR/Personnel Officer, Marketing Officer, etc. To fit into the IBPS SO Eligibility Criteria 2024, you need to fulfill these qualifications. The snippets below show the educational qualifications required for each post.

IBPS SO Exam Pattern 2024

Understanding the exam pattern is crucial to excelling in your exams. It will help you strategize your study plans and manage time effectively. You will have to go through three stages: the preliminary examination, the main examination, and the interview process.

Preliminary Examination:

There are two patterns for IBPS SO prelims examination for different posts. You have to qualify in each of the three tests by securing minimum cut-off marks to be decided by IBPS.

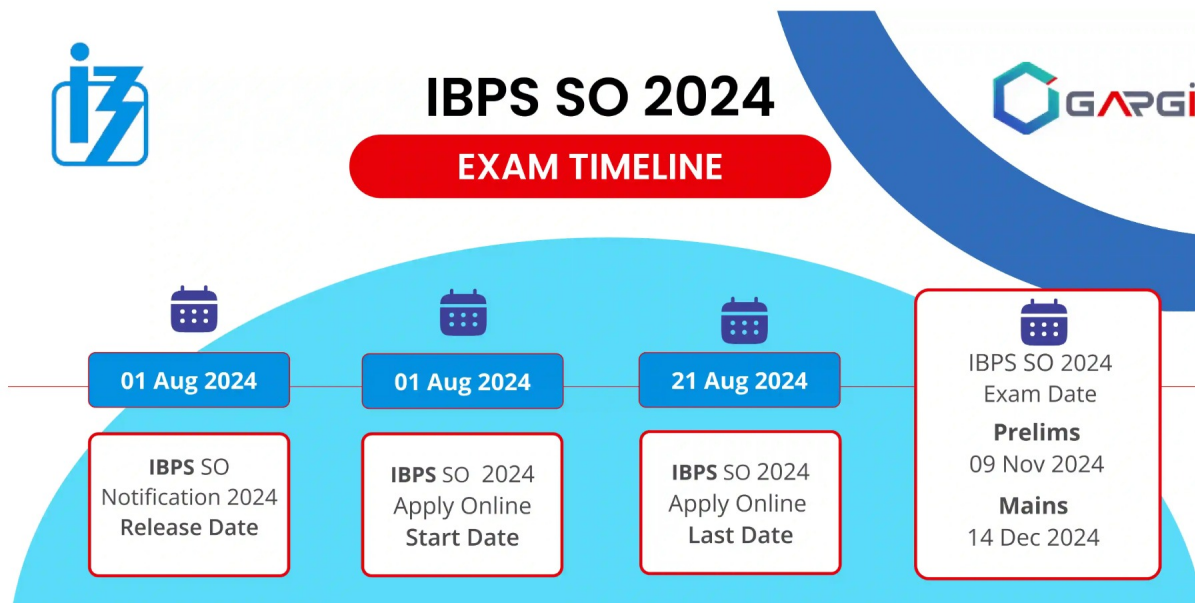
Main Examination

- **Law Officer, IT Officer, Agriculture Field Officer, HR/Personnel Officer and Marketing Officer:** Professional Knowledge
- **Rajbhasha Adhikari:** Professional Knowledge (Objective) and Professional Knowledge (Descriptive).
