

Nationality:

Candidate applying for SBI PO Exam 2024 must be:

1



- · You must be an Indian citizen.
- Alternatively, you can be a subject of Nepal or Bhutan.
- Tibetan refugees who arrived in India before January 1, 1962, with the intention of permanent settlement, are eligible.
- Persons of Indian Origin (PIO) who have migrated from Burma, Pakistan, Sri Lanka, Vietnam, or East African countries (Zaire, Kenya, Tanzania, Uganda, Zambia, Ethiopia, or Malawi) with the intention of permanent settlement in India, can also apply.
- If you fall under categories 2, 3, or 4, you must have a certificate of eligibility issued by the Government of India to apply for SBI PO 2024.

Age Limit:

• For SBI PO exam, you must be between 21 and 30 years old.

Furthermore, we have provided the Age Relaxation for certain categories:

Sr.	Category	Age relaxation
1.	Scheduled Castes/ Scheduled Tribes	5 Years
2.	Other Backward Classes (Non-Creamy Layer)	3 Years
3.	Persons with Benchmark Disabilities (PwBD) - PwBD (SC/ST)	15 Years
	- PwBD (OBC)	13 Years
	- PwBD (Gen/ EWS)	10 Years
4.	Ex Servicemen, Commissioned officers including Emergency Commissioned Officers (ECOs)/ Short Service Commissioned Officers (SSCOs) who have rendered 5 years military service and have been released on completion of assignment (including those whose assignment is due to be completed within one year from the last date of receipt of application) otherwise than by way of dismissal or discharge on account of misconduct or inefficiency or physical disability attributable to military service or invalidment.

Educational Qualification:

The educational qualifications needed for the SBI PO Exam 2024 are as follows:

- You must have graduated in any discipline from a recognized University or have an equivalent qualification approved by the Central Government.
- If you're in your final year or semester, you can still apply, but you need to provide proof of graduation on the interview date.

Number of Attempts:

Here are the maximum attempts allowed for SBI PO based on your category:







- If you belong to the General or EWS category, you can attempt the exam up to 4 times.
- For those in the General (PwD) or EWS (PwD) categories, you're allowed 7 attempts.
- If you're in the OBC category, you also get 7 attempts.
- OBC (PwD) candidates can attempt the exam up to 7 times as well.
- If you fall under the SC, SC (PwD), ST, or ST (PwD) categories, you have no restrictions on the number of attempts.

SBI PO Exam Pattern 2024

The SBI PO selection process consists of three stages. The written examinations are conducted online, followed by an interview round. The structure of the exams is as follows:

SBI PO 2024 Preliminary Examination

- The online examination lasts for 1 hour and is worth 100 marks.
- There is a negative marking of 1/4 marks for each incorrect answer.
- The test comprises 3 sections, and there is no sectional cut-off in the Preliminary Exam; the overall score across all sections determines selection to the next round.

SBI PO 2024 Mains Exam Pattern

- The SBI PO Mains Exam consists of an Objective Paper lasting 3 hours and a Descriptive Paper lasting 30 minutes.
- The Objective Paper includes sections on Reasoning & Computer Aptitude, Data Analysis & Interpretation, General/Economy/Banking Awareness, and English Language.
- The Descriptive Paper includes 2 questions and is conducted alongside the online test. There is a penalty of 0.25 marks for each incorrect answer in the Objective Paper; no marks are deducted for unanswered questions.
