Nationality

To be eligible for this exam, you should be:

- Citizen of India, or
- A subject of Nepal, or
- A subject of Bhutan, or
- Tibetan refugee who came over to India before 1st January 1962 to permanently settle in India, or
- A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, east African countries of Kenya, Uganda, the United Republic of Tanzania, Zambia, Malawi, Zaire, Ethiopia, and Vietnam with the intent to permanently settle in India.

Please note that if you belong to any of the above-mentioned categories other than being a citizen of India, you would have to present a certificate of eligibility issued by the government of India.

Age Limit (As on 01.08.2024)

To be eligible for the IBPS PO exam 2024, your age should be between 20 and 30 years.

Educational Qualification

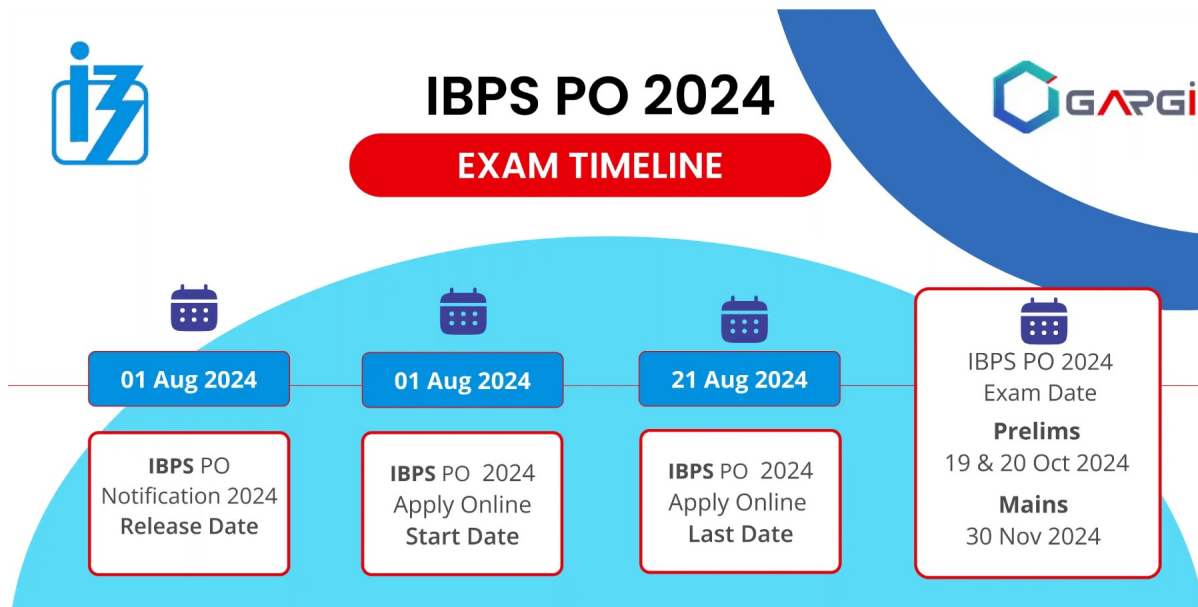

released on January 15, 2024, the IBPS PO preliminary examination is scheduled for October 19, 2024, and October 20, 2024. The admit cards for this exam are expected to be issued in the first or second week of October. The main examination is set for November 30, 2024, approximately one month after the preliminary exams, with admit cards for the main exam likely to be issued by the end of October 2024.

The registration will be conducted exclusively online, with a single registration covering both the preliminary and main examinations. To proceed, you will need to follow the steps outlined below:

- **Visit the Official Website:** Go to the official IBPS website using the provided link.
- **Initiate New Registration:** Click on "Click here for New Registration" on the homepage.
- **Provide Basic Information:** Fill in your basic details to complete the registration. You will receive a provisional registration number and system-generated password upon successful registration.
- **Fill Application Form:** Carefully complete the online application form for IBPS PO 2024. Review each section and click "Save and Next". Once you click "FINAL SUBMIT", no further changes can be made.
- **Upload Documents:** Upload scanned copies of your photo, signature, and handwritten declaration as per the specifications provided.
- **Select State Preference:** Indicate your preferred state for application. This choice cannot be modified after the final submission.
- **Make Payment:** Proceed to make the online payment using a credit card, debit card, or net banking.
- **Save Receipt and Application:** After successful payment, save the e-receipt and a copy of the completed application form for future reference.

IBPS PO Notification 2024 - Application Fees

The application fees or intimation charges for the IBPS PO exam, payable from August 1, 2024, to August 21, 2024 (inclusive of both dates and only through online payment), are as follows: Rs. 175/- (inclusive of GST) for SC/ST/PwBD candidates and Rs. 850/- (inclusive of GST) for all other candidates. Please note that the bank transaction charges for online payment of application fees or intimation charges will need to be borne by you.

- The IBPS PO preliminary exam consists of 100 objective type questions.
- The maximum score for the preliminary examination is 100 marks.
- Each correct answer earns you 1 mark. However, for each incorrect answer, 1/4 of the allotted mark will be deducted as a penalty.
- The duration of the preliminary examination is 60 minutes.

- For each incorrect answer, 1/4 of the assigned mark will be deducted as a penalty.
- The duration of the examination is 180 minutes.
- Moreover, in addition to the 155 objective-type questions, there will be 2 descriptive questions in main examination on the English Language (Letter Writing and Essay) worth 25 marks. You will have 30 minutes to complete these 2 descriptive questions.
- You must qualify for the preliminary examination to attend the main examination.
