

Nationality

In order to be eligible for the IBPS SO 2024, you must fit into certain nationality criteria. Hence, you must be:

- a citizen of India or
- a subject of Nepal/ Bhutan
- a Tibetan Refugee, who came to India before 1st January 1962 with the intention of permanently settling in India or
- Persons migrated from India from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

If you belong to any of the above-mentioned last three categories, you must possess a certificate of eligibility issued by the Government of India.

Educational Qualification

The required qualification to be eligible for IBPS SO 2024 varies according to the post you are applying for:

- For the post of **IT Officer (Scale I)**, candidates must have a -
 - 4-year Engineering/ Technology Degree in Computer Science/ Computer Applications/ Information Technology/ Electronics/ Electronics & Telecommunications/ Electronics & Communication/ Electronics & Instrumentation Or
 - Post Graduate Degree in Electronics/ Electronics & Tele Communication/ Electronics & Communication/ Electronics & Instrumentation/ Computer Science/ Information Technology/ Computer Applications Or
 - Graduate degree having passed DOEACC 'B' level.
- For the post of **Agricultural Field Officer (Scale I)**, candidates must have a 4-year Degree (graduation) in Agriculture/ Horticulture/Animal Husbandry/ Veterinary Science/ Dairy Science/ Fishery Science/ Pisciculture/ Agri. Marketing & Cooperation/ Co-operation & Banking/ Agro-Forestry/Forestry/Agricultural Biotechnology/ Food Science/ Agriculture Business Management/ Food Technology/ Dairy Technology/ Agricultural Engineering/ Sericulture.
- For the post of **Rajbhasha Adhikari (Scale I)**, candidates must have a Post Graduate Degree in Hindi with English as a subject at the degree (graduation) level or a Postgraduate degree in Sanskrit with English and Hindi as subjects at the degree (graduation) level.
- For the post of **Law Officer (Scale I)**, candidates must have a Bachelor's Degree in Law (LLB) and enrolled as an advocate with Bar Council.
- For the post of **HR/Personnel Officer (Scale I)**, candidates must have a Graduate and Two Years Full-time Post Graduate degree or Two Years Full-time Post Graduate diploma in Personnel Management / Industrial Relations/ HR / HRD/ Social Work / Labour Law.
- For the post of **Marketing Officer (Scale I)**, candidates must have a Graduate and Two Years Full time MMS (Marketing)/ Two Years Full-time MBA (Marketing)/ Two Years Full time PGDBA / PGDBM/ PGPM/ PGDM with specialization in Marketing.

Age Limit (As on 01.08.2024)

In order to be eligible for the IBPS SO 2024, you must fall between the age range of 20 to 30 years. Moreover, there are certain relaxations provided to some categories regarding the eligible age limit.

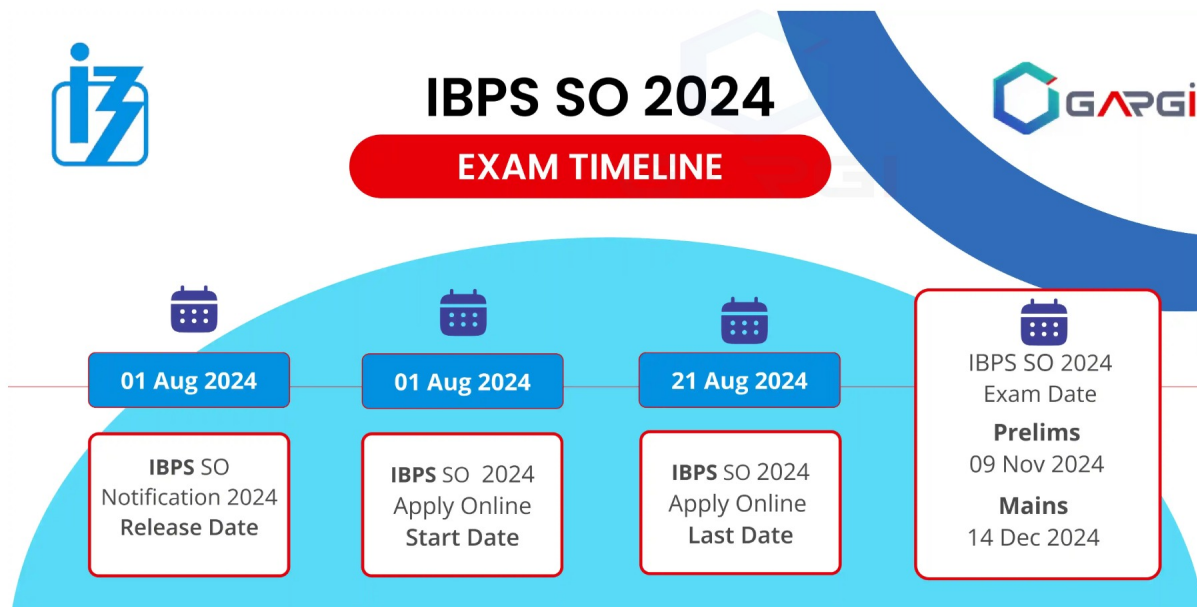

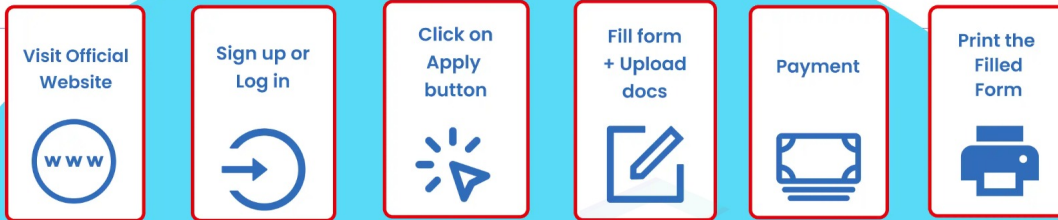

- Go to the official IBPS website.
- Click on “Click here for New Registration” on the homepage.
- Fill in your basic details to complete the registration. You will receive a provisional registration number and a system-generated password upon successful registration.
- Carefully fill out the online application form for IBPS SO 2024. Review each section and click “Save and Next.” Once you click FINAL SUBMIT, no further changes can be made.
- Upload scanned copies of your photo, signature, and handwritten declaration as per the given specifications.
- Choose your preferred state for the application. This selection cannot be changed after the final submission.
- Proceed to make the online payment using a credit card, debit card, or net banking.
- After successful payment, save the e-receipt and a copy of the completed application form for future reference.

IBPS SO 2024 Application Fees

You can apply online only for IBPS SO exam 2024, as no other mode of application will be accepted. The application fees/intimation charges, payable online from August 1, 2024, to August 21, 2024 (both dates inclusive), are Rs. 175/- (inclusive of GST) for SC/ST/PwBD candidates and Rs. 850/- (inclusive of GST) for all others. You will need to bear the bank transaction charges for the online payment of these application fees/intimation charges.

The IBPS SO exam pattern consists of three phases: preliminary, main, and interview. The preliminary exam is qualifying in nature and includes three sections, totaling 125 marks. The preliminary exam should be completed within a timeframe of 2 hours. The main exam is worth 60 marks. Candidates must qualify in all stages by achieving the cutoff marks set by the exam authorities.
