

• Subjects Covered: Test of Reasoning(50 questions), Quantitative Aptitude(35 questions), and English Language(35 questions)

• Subjects Covered: General IT Knowledge(25 questions) and Role-Based Knowledge(50 questions)

SBI SO Notification 2024 - Marking Scheme
