Eight people of a family are working in a company on different designations i.e. CMD (senior-most), MD, CEO, COO, AO, Manager, Admin, and Clerk (junior-most). There are three married couples. The brother of K is not the CEO. The mother of P is junior to her daughter. Three people are designated between M and his brother-in-law, who is not a Manager. Three people are designated between S and the wife of N. L is the sister-in-law of K. J is married to S, who is the sister of M, who is the nephew of N. U is junior to N but not immediately. P is the granddaughter of U and is junior to her father but not immediately. L is junior to the son of K but not immediately. The wife of J is junior to the Manager. U, who does not have a sibling, is the husband of K, who is the sister of N.

Question

Find the odd one from the following.

Difficulty : Moderate

Options:

1. M, K

2. S, U

3. K, J

4. L, N

5. N, S

Average Time: 75 Seconds

The correct answer is Option 5 i.e. N, S

1. J is married to S, who is the sister of M, who is the nephew of N.








- 2. U, who does not have a sibling, is the husband of K, who is the sister of N.
